Dear Parents and Guardians,

Sub: Fee Structure for Academic Session 2022-23

We hope that you have remained safe and all members of the family are healthy. We thank you for your cooperation in the difficult times the School has faced over the past two Academic Sessions. You will agree that the School too has tried its best to keep the learning process of your ward on, even under the most trying of circumstances. That would not have been possible if our teachers and some of our other staff would not have taken up the challenge to continue with reaching classes to our pupils, when the world outside our windows came to a grinding halt.

The time has come to look ahead and plan for the Academic Session 2022-23. With that purpose in mind, the Managing Committee of the School has approved of the fee structure which will be applicable for all students for the academic session 2022-23. You will find the fee structure applicable to your ward in the attached document.

We also draw your kind attention to the Order dated December 17, 2021 in WPA 5890 of 2020 and other related matters passed by the Hon'ble Division Bench of Calcutta High Court. By the said order, the Hon'ble Court has passed directions, inter-alia, that the School shall by 15th February 2022, send to all parents/guardians an estimate of fees and additional charges for compulsory facilities to be provided and service to be rendered as well those of optional facilities. The Hon'ble Court has further directed that all students (except those who are to appear in Board Examinations) have to be readmitted into the School from 15th March 2022 and that such readmission will be done only if the fees and charges are paid by the said date.

Accordingly, all guardians who wish to continue their ward's education at South Point School beyond the current Academic Session are required to respond to this notice and submit a statement in the enclosed format, with regard to continuation of their ward in this School. In case any guardian does not wish to continue their child at South Point School, they are requested to visit the School and contact the School Office to clear the previous dues, if any and as applicable to them, on any working day between March 15, 2022 and March 25, 2022. Those who wish to continue with this School and have part of their fees for the academic year 2021-22 still lying unpaid, may contact the School Office of the School on any working day between February 28, 2022 and March 10, 2022 to

know their outstanding amount and clear the same. If any part of the School Fee for a child remains unpaid after March 15, 2022 or if the statement in the enclosed format is not received by the School, it will be presumed that the Guardian/Parents of the child are not willing to continue him or her at this School from the next Academic Session, and appropriate steps will be taken in terms of the rules of the School.

The School will extend all administrative support to any Parent who would like to withdraw their ward before the next session. Academic progress for the session 2021-22 will not be hampered, keeping in view the academic needs of the concerned pupil. We sincerely hope that all pupils will be in a position to continue their education in South Point School.

Guardians can take a print of the enclosed format or collect a hard copy of the same from the School reception. They need to fill the printed copy, sign and submit the same to the School in any of the two methods: (1) through the Helpdesk module available on Skolaro by raising a ticket under the Ticket Type — Undertaking in respect of each child and attaching scanned copy of the signed statement (in pdf or jpeg format) in the space given therein; or (2) submitting the signed statement physically at the School reception (please carry an extra copy in case you need a receipt). The last date for submission of the said statement is February 25, 2022. Please note that for those willing to continue their wards' education at South Point School, it is COMPULSORY to submit the statement.

We will communicate with you soon about our detailed academic plans for the coming academic session, which at present is dependent on the prevailing situation as well as directives from Government and the Board. We shall continue to follow all directives from the State Government from time to time and conduct classes in the next academic session in online mode as well as on campus, as the pandemic situation demands, and the government allows.
